Since November 2020, the division hosts the Office of Racing, which provides policy advice and administers programs to build a sustainable Queensland racing industry.

Your opportunity

As the Executive Principal Education Officer you will:

- Oversee, coordinate and manage complex statewide school improvement strategies, projects and services in accordance with departmental policy and procedures and adhering to legislative and regulatory requirements.
- Provide strategic expert educational and professional advice, consultancy and dispute resolution services regarding complex matters to facilitate innovative business outcomes.

The Executive Principal Education Officer reports to the Executive Director/Regional Director in the relevant location.

Your role

As the Executive Principal Education Officer you will have responsibility for the following:

- Lead strategies and provide high level management to project teams that foster high quality collaboration, communication and information sharing to enable an understanding of the complexities and challenges that exist in the targeted area.
- Provide high level guidance on training and coaching opportunities to build capability and capacity across the department for the delivery of evidence-based practices.
- Engage effectively with stakeholders across the department to develop integrated approaches to complex matters to foster an integrated approach to deliver the vision of the department.
- Develop integrated statewide strategies, manage projects and deliver improvement services using recent school based experience and superior level knowledge of teaching, learning and school improvement strategies.
- Maintain strategic partnerships with internal stakeholders and external agencies and effectively represent the department at high level internal and external forums and meetings.
- Develop solutions to complex matters through effective research, analysis and consideration of the department's goals and objectives.
- Interpret, consult, mediate, negotiate and resolve issues that may impact the implementation of initiatives and provide innovative solutions to align to statewide frameworks and processes.
- Lead the interpretation, application and effective implementation of department policy, procedures, legislation and other regulatory provisions, especially with regard to complex matters relating to statewide strategies, projects and services.
- Oversee and prepare complex reports, correspondence, briefing notes and submissions for senior and executive management, the Minister and other audiences on significant departmental issues.
- Exhibit and foster superior level commitment to developing performance and knowledge of best practice approaches to teaching, learning and school improvement.

Eligibility requirements:

You must be a permanent employee of the department with a substantive teaching or classified officer role employed under *Teaching in State Education Award – State 2016*, have current full registration as a teacher and should be aware that temporary internal moves for the purposes of the department's payroll processes are referred to as internal secondments.

Employees' engaged temporarily as Education Officer - Special Duties have a requirement of 36¼ hours per week attendance and arrangements as outlined in *clause 7.4 of the Department of Education State School Teachers Certified Agreement 2019*.

How you will be assessed

Within the context of the role described above, the ideal applicant will be someone who has the following key capabilities:

1. Advanced leadership and management skills with a superior ability to interpret and develop comprehensive policy advice regarding complex matters to shape decision making in a state school setting.
2. Demonstrated superior analytical and problem solving skills to support organisational capability and responsiveness, and contribute toward innovative solutions to complex matters.
3. Support ongoing effective working relationships with a diverse range of stakeholders, working collaboratively in a complex operating environment to achieve business outcomes.
4. Focused commitment to action and the ability to interpret and apply policy, procedures, legislative and regulatory provisions to complex and sensitive circumstances to achieve corporate outcomes.
5. Superior written, oral and interpersonal communication skills including mediation and negotiation skills, as well as the ability to interpret, develop and communicate innovative business outcomes for a complex client base.
