### Your opportunity

As the Physiotherapist, you will:

- Support children and students to access and fully participate in learning and experience success and wellbeing across all stages of learning, in an inclusive education system supported by reasonable adjustments and teaching strategies tailored to meet their needs.
- Apply your professional skills and knowledge in contemporary physiotherapy and collaborate with education teams within schools to deliver high quality physiotherapy services which address barriers to student learning and enhance educational outcomes.

The Physiotherapist reports to the base school Principal for operational and administrative matters and to either the Senior Regional Advisor, Physiotherapy or Senior Physiotherapist (Supervisory) on all professional practice and clinical practice matters.

### Your role

Appointments in the public sector are merit-based and will be assessed by looking at what you have done previously—the knowledge, skills and experience you have built, your potential for development, and your personal qualities.

Responsibilities include:

- Support students to achieve their potential using evidence-based contemporary physiotherapy knowledge and frameworks to assist schools to identify and make reasonable adjustments and implement inclusive teaching strategies.
- Collaborate and liaise with school leaders, teachers, other service providers, and the supervising physiotherapist to assess barriers to student learning and participation and develop and implement physiotherapy services across schools.
- Participate as an active member in education teams within schools to ensure the delivery of high quality, evidence-based contemporary physiotherapy services to enhance learning outcomes for students with disability.



- Monitor and assess physiotherapy services provided across schools, in consultation with the supervising physiotherapist, to ensure that they improve student access and participation in education.
- Develop and implement best-practice assessment, program planning, intervention and monitoring strategies for students with disability, in accordance with legislation, departmental policies, procedures and guidelines.
- Provide consultative physiotherapy services and resources to assist school leaders and staff, parents, and other professional peers to develop knowledge and skills to support students with disability.
- Participate as a member of the school team, in the planning and management of at risk behaviours of students with the aim of preventing the use of restrictive practices, and where permitted, the prescription of mechanical restraint in accordance with the department's Restrictive Practices procedure.
- Prepare written reports and maintain records related to the delivery of physiotherapy services as required by the department.
- Participate in service planning at a school level.
- Participate in the development, implementation, evaluation and monitoring of governance processes.
- Participate in quality improvement and research activities enhancing physiotherapy services in schools.
- Actively participate in, professional development activities and clinical supervision to improve and ensure high quality services are delivered based on contemporary best practice.
- Maintain registration as a physiotherapist, currency of knowledge and skills relating to the department generally, and the provision of physiotherapy services in education.
- Supervise university physiotherapy students.

#### **Other responsibilities (as required)**

- Other suitable duties, consistent with the duties and responsibilities of the position as directed by the supervisor or nominated delegate.

#### **A mandatory requirement of this role is:**

- Possession of a degree in physiotherapy from a recognised tertiary institution, or other equivalent formal qualifications which, in the opinion of the Director-General, Department of Education, or delegate, are acceptable.
- Current registration with the Physiotherapist Board of Australia (Australian Health Practitioner Regulation Agency).
- In accordance with the [Working with Children \(Risk Management and Screening\) Act 2000](#), registered health practitioners working within their professional capacity must hold valid registration with the Australian Health Practitioner Regulation Agency at all times during their employment for the purpose of satisfying the exemption requirements of the Act.
